\* For the legal entity used on product labeling and documentation, regulations allow for use of manufacturing Legal Entity or Distribution (Sales) Legal Entity. Most manufacturing sites use their Manufacturing Legal Entity details on product labels and documentation. However, there are some exceptions. Whatman products produced in China (Tonglu), UK (Cardiff) and Germany (Dassel) use the UK Sales Legal Entity for their Product labels and documentation, which will change at deal closure.

\*\* The change in legal entity name for HyClone products is effective from 30 September 2019: Company name on label and Certificate of Analysis (CoA): Preceding this legal entity change, an alignment between label (where no legal entity was stated) and CoA (where legal entity HyClone Laboratories Inc was stated) lead to the change to remove "Inc" from the address line of the CoA in order to match the product labels. CoA and label for HyClone products do not include legal entity suffix, they only state "Hyclone Laboratories"
